
# Survey report on corruption










### II. Corruption related questionnaire




#### 2.2 . Through which channels do you get information about corruption?




### **2.3** What is corruption in your opinion?



• In your opinion, how the level of corruption changed in Mongolia in the last two years?




• In your opinion, how the level of corruption will change in the coming two years?




People generally have negative expectations about the level of corruption in the future.

In your opinion, how the level of corruption changed in your soum in the last two years? 46 per cent of
the survey participants answered that they do not know, which shows that on one hand, people are
generally inactive when it comes to searching for information, on the other hand, it is related to the
transparency of government activities as well as advocacy and provision of information by the local
government institutions.




• In your opinion, how the level of corruption will change in your soum in the coming two years?




# III. Transparency related questionnaire


To the question "Can you access information related to decisions made by government institutions, government officials /rules, regulations, standards/ at any time?" people answered in the following way. Conclusion can be drawn that such information is accessible to people depending on their will to search for it.




 Information related to decisions /rules, regulations, standards/ made by government institutions, government officials is in an easily understandable format.




To the question "Can you access information related to the budget and financial activities of your local
government at any time?" It can be concluded that government institutions, government officials tend
to be less transparent on the matters regarding the budget and financial activities, therefore people
expressed hesitation on the accessibility of such information.




Can you freely get your desired information from your local government institutions?



• To the question "Can you freely get information related to budget and financial activities of your local government?" 31 per cent of the survey participants were hesitant.

**Conclusion** 

Following conclusion can be drawn based on results of the survey:

- People watch corruption related information only if it is shown on media, however they lack the
  initiative to search for information themselves or refer to public institutions, authorities regarding the
  matter.
- Budget and finances of government institutions are less transparent compared to other activities.
- Some people in the rural areas refrained from taking the survey and instead suggested to ask the authorities rather than them.
