
# Three. MNPBT in the state of emergency and state censorship

Mongolian National Public Broadcasting Television worked for four days since the declaration of the state of emergency by President's decree on July 1. During this period, the state restored its strict censorship in MNPBT and took it under state control. In doing so, voices of media organization were restricted and expressions and positions of ordinary citizens, scholars and experts were pressed down with a failure of social justice.

#### MNPTB, July 5, 2008, 00:11-00:21 o'clock 618 seconds

... The state of the emergency has been lifted. Over the past period, MNRTB broadcast its program and information under the direct supervision of Operative Headquarter of the National Security obeying the Law on State of Emergency...

For days the under state supervision, 51.1 percent of sources broadcast by MNPBT was the official or from representation of the government. 4.1 percent of coverage was sourced from citizens, 3.2 percent from NGO representation and 0.1 percent was from experts and observers.

Information saying "Civil Coalition and the Republican Party and its leaders are guilty" was at least 5.5 percent on July 1. In the course of working days under the state strict supervision, this information had gradually increased to 22.6 percent. As well as information claiming "Eagle Television is inciting" was covered 6.3 percent.
