On the occasion of World Press Freedom Day, Globe International Center organized a discussion event on May 2, 2018 on the basis of the UNESCO National Mongolian Commission and the Mongolian Bar Association. UNESCO issued the International Freedom of the World in 2018 entitled "Empowering the Authority" under the theme of Media, Justice, and Law. Globe International Center has also celebrated World Freedom Day in this topic. • In 2017, there were 182 violations of professional rights related to 91 journalists and media.

GIC's annual Media Freedom Award "For the Truth" presented to Ms. U.Bolortuya journalist of EagleTV. U.Bolortuya had prepared investigative serial reportings since 2012 such as "Forgotten Sukhbaatar monument", "Silent scream", "Budget money of disability kindergarden's children".





# **The Cartoon Competition Award 2018**

Globe International Center and the Mongolian National Commission of UNESCO announced cartoon competition "The Freedom of Expression of the Digital Environment" among students and youth on the occasion of the International Freedom Day celebration with the support of the Embassy of Mongolia in France.

#### MONGOLIAN MEDIA FREEDOM REPORT 2017

The theme of this year's WPFD is Keeping Power in Check: Media, Justice and Rule of Law as defined in the UNESCO Concept Note. Free, independent and ethical media is main dimension of the healthy and fair society.



2017 has given many tasks to think of and make judgment in media freedom issues. The campaigning of the Presidential Election that took place in 2017 was one of those. The voters of Mongolia witnessed how media and social media channels were abused and manipulated by dirty technology of the political election.

That is why we welcome the UNESCO WPFD sub-themes: Free press, access to information and election, the justice system supporting free and safe journalism, and freedom of expression online: improving self-regulation.

In 2017, Mongolia is in the 71st place out of 180 world countries and it is still the country is with noticeable problems of press freedom.

Globe International Center has recorded a total of 182 cases of violations as results of the free expression monitoring. More than 30 percent of free expression violators are politicians, high authorities, public officials and public bodies. The report notices that editorial censorship has increased in 2017. In 2017, the Mongolian courts heard a total of 12 civil and no criminal defamation cases.

# INTERNATIONAL DAY TO END IMPUNITY FOR CRIMES AGAINST JOURNALISTS

GIC held a press conference at Mongol News media center on November 1<sup>st</sup>, 2018 to commemorate The International Day of End to Impunity for crimes against journalists. GIC conducted with Mongolian Bar Association and Mongolian media council have prepared report "Legal environment for media freedom and Journalist safety indicator". The first outcomes of the Monitoring Report on the Safety of Journalists were presented during the press conference and the monitoring is conducted by the framework of the project "Promoting Human Rights and Labour Rights through GSP+ mechanism", that was implemented by Globe International Center.

# "Promoting human rights through GSP+ mechanism" inception workshop

The Inception workshop was held from April 13 to 14, 2018 at Puma Imperial Hotel in Ulaanbaatar and it involved a total of 98 participants: 69 female and 29 male.

In his speech, Mr. Marco Ferri mentioned that while the GSP report points to positive developments Mongolian in implementing the 27 conventions, he highlighted a few issues of concerns: President's proposal to reinstate the death penalty, concrete measures to implement the international environment and climate conventions would need to be strengthened and absence of progress in enacting an adequate legislation to comply with the CITES Conventions.





#### **Outcomes:**

Representatives of all stakeholders:

- 1. Informed in the project and its partners
- 2. Gained knowledge on GSP+ mechanism and Mongolia context
- 3. Discussed the issues of human and labor rights in the country and its challenges by asking the questions and exchanging their views and opinions
- 4. The participants of the second day contributed to the development of Outreach and Dissemination Plan and communication matrix for the project's media campaign
- 5. They came up with their ideas to the development of agendas for the NGO and Media training
- 6. The general public informed in GSP+ mechanism and it is relation to human and labor rights issues through media news coverage.





The Inception workshop gathered 98 representatives from all stakeholders and 20 participants from 19 aimags (provinces): 13 representing the MCC, 6 - NHRC and one local media of the Kazakh minority in Bayan Ulgii aimag. 35.7 percent of the participants represented the civil society, 27.5 percent -the government agencies and NHRC, 15.3 percent-business community and 14.2%- international community including six embassies, and percent represented the local media.

## **Training for the Human Rights NGOs**

The two-day training was held on 21-22 June 2018 at National Legal Institute and it involved a total of 20 participants; 17 female and 3 male representing NGOs from the capital and 6 aimags (provinces). The participants represented media NGOs and civil society groups working on human rights' issues on LGTBI (1), disabilities (1), women (2), media right (6) women's economic rights and right to education (3), law (3) as well as representatives of the trade union and lawyers-members(4) of the Mongolian Bar Association.

#### **Outcomes**;

Participants gained the knowledge on:

- 1. Project objectives as well as expected outcomes
- 2. GSP+ mechanism and Mongolia context
- 3. Concepts of human rights, UN mechanisms and tools.

- 5. International standards of freedoms of opinion and expression and its restrictions and domestic legislation
- 6. Types of free expression violations and an effective alerting.
- 7. Human rights restrictions: ethics, privacy and social morals

## Training for the media journalists



The two-day Media training was held on 3-4 July, 2018 at the Training room of the Mongolian Employers' Federation.

The Media training involved a total of 20 journalists: 16 female and 4 male from the mixed group of broadcast (6), print (3) and online media (10) outlets as well as Information and Communication Officer of the UNESCO NATCOM.

The Media training reached its goal to improve in reporting on obligations and duties of the Mongolian government and reinforcing public discussions on GSP+ processes. The journalists contributed to the Communication Matrix, which is elaborated as a main guide for the media campaign.

#### **Outcomes:**

The participants provided the knowledge on:

- 1. 7 core human rights and eight labour rights conventions covered by GSP+, its status of Mongolia, the UN human rights' mechanisms
- 2. Human Rights Indicators of the OHCHR.
- 3. International trade, specially export, international investment, WTO principles and guidelines as well as UN Business and Human Rights principles, and HRC Working group on business and human rights
- 4. Professional principles of human rights reporting and ethical reporting
- 5. Right to Opinion and Freedom of Expression: Government obligations and duties
- 6. Safety of Journalists, UN Acton Plan and UNESCO Journalists' Safety Indicators

# "Transparency and Accountability in Mongolian Education" project


Under this Program, GIC has been implementing Transparency and Accountability in Mongolian Education (TAME) for the fourth year successfully. The main partners of TAME project are "All for Education" National Civil Society Coalition. (Mongolian NGO working towards the sustainable nation-wide changes in education policy and system) and Partnership for Transparency Fund (NGO based in USA). This four-year project is funded by Global Partnership for Social Accountability (GPSA), World Bank.





# "Transparency and Accountability in Mongolian Education" project

Establishing 2 additional PTAs in non-target schools was a spill-over effect of the project that PTAs have established a rather good start in the education sector of Mongolia. The initiative started by the former school principal of the target school, which whole-heartedly supported by the head of Education Department show that pilot design had been successfully implemented. At the end of project implementation, a total of 32 PTAs, including National PTA were established in Mongolia.



The project aimed to improve transparency and accountability of budget and procurement in education sector by implementing BTT at the aimag level. For example, Transparency of the budget information in Khuvsgul aimag has increased significantly over the project period. Through qualitative data collection, the following change can be illustrated as a positive impact on particular aspects of the transparency in education.



Parents and teachers are undertaking various activities such as raising funds for school repairs and organising cultural events etc, as part of PTA action plan. PTA members are being invited to join the School Board as the parent representatives, asking to be consulted on child rights issues, and being asked to play impartial and monitoring function to school activities such as school lunch. The school principals are seeking support from PTA's advocacy approach to receive additional funding from the local government in the monetary and non-monetary forms.

# Better school learning environments created due to fostering of public-private partnership

Some target schools renovated the doors and roof thanks to the local business sponsorship after PTA's discussion with the private sector and local government. Some PTAs have been able to secure financing from Local Development Fund to replace the old chairs and tables at the school.



# "National Forum: Good practices & lessons learned of TAME project"



The National Consultation Forum were attended by specialists from the Ministry of Education, Culture and Science, Anti-Corruption Agency and Family Children and Youth Development Agency. Furthermore, around 140 PTA's representatives of Policy developers, public officers of MECSS, MoF, IAAC, aimag representatives, PTA & NGO representatives, scholars and scientists working in the education sector.



# Discussions on the implementation of the PTAs' Good Practices and GSST

In the first part of the program was discussed by "Good Practices of School Parents and Teachers Association". The following section was continued by the topic "The Implementation and Importance of Good School's Supporting Tools".

Representatives of PTAs' said that "By implementing the GSST, we have seen things that have never been before. Since, we were using the GSST tools every time we look at what's going on in the school environment, I feel that i have to improve it. The feeling is gathered us in one purpose that is improving school environment.





#### **IPDC TALKS MONGOLIA 2018**

Globe International center organized IPDCTalks Mongolia in the second year on the International day for Universal Access to Information joint with Mongolian National Commission of UNESCO, Deutsche Welle Academy and the Open Society Forum on September 25, 2018. IPDCtalks Mongolia 2018 was organized under the theme "Strengthening Sustainable Development Goals with Access to Information".





### Visibility of the project IPDCTalks 2018

Press releases of IPDCtalks Mongolia 2018 were published on 5 national websites (gogo.mn, ikon.mn, etoim.mn, montsame.mn), a newspaper (Mongolian news) and a magazine (Mongolian economy). During the conference TV channels (MM agency, MNB world) interviewed speakers and the conference participants and those interviews were broadcasted nationwide. In addition, TV discussion was held on Eagle TV on that day.

#### 48 HOUR SHORT FILM FESTIVAL 2018





The GIC team successfully organized "48 hours Mongolia-2018" short film festival for the 9th consecutive year in Ulaanbaatar. The festival was huge success in 2018, attracting 420 budding film makers of 29 teams which indicate that festival has become one of the most desirable events in Mongolian film industry.

The award ceremony of the Naadam Festival was held on October 12, 2018 at the Black box Theatre which gathered representatives from movie makers, sponsor organizations, embassies, international organizations and civil society.

After the judges' team evaluation the short film called "Shit happens" was awarded the Grand Prix of 48 hour Mongolia, created by "Shit happens" team. Winning team was invited to participate in 2018 International festival in New Orleans, France and won the right to compete with the best international films.




